The Aror University of Art, Architecture, Design & Heritage, Sukkur invites sealed bids under the Single Stage–One Envelope procedure from eligible individuals and firms duly registered with and appearing as Active Taxpayers on the records of the Federal Board of Revenue (FBR) and Sindh Revenue Board (SRB), for the auction/disposal of unserviceable stores and scrap material available at Aror University, Sukkur, on an "As Is, Where Is" basis.

Interested bidders may inspect the auction material at Aror University, Sukkur, during working hours (09:00 AM to 04:00 PM) up to August 06, 2026. The sealed bid(s), on the prescribed Bid Form, along with a non-refundable tender fee of Rs. 3,000 in the form of a Pay Order/Demand Draft/CDR in favor of The Aror University of Art, Architecture, Design & Heritage, Sukkur, shall be submitted to the office of the Procurement Officer by 12:00 p.m. on August 7, 2026. The bids will be opened on the same day at 12:30pm.

The auction shall be conducted strictly on an "As Is, Where Is" basis and no claim regarding the quantity, quality or condition of the material shall be entertained after submission of bids. The successful bidder shall deposit the full auction amount within seven (07) working days of issuance of the Letter of Acceptance, failing which the award shall stand cancelled. The successful bidder shall remove the auctioned material from the University premises at their own cost within three (03) working days after full payment and issuance of the Release Order. The Procuring Agency reserves the right to reject any or all bids or cancel the auction process at any stage in accordance with Rule 25 of the Sindh Public Procurement Rules, 2010 (as amended from time to time).
