NO.PAS/LEGIS-B-11/2019-The Aror University of Art, Architecture, Design and Heritage, Sukkur, Bill, 2019 having been passed by the Provincial Assembly of Sindh on 15th June, 2020 and assented to by the Governor of Sindh on 07th July, 2020 is hereby published as an Act of the Legislature of Sindh.

SINDH ACT NO. IX OF 2020

AN

to provide for the establishment of the Aror University of Art, Architecture, Design and Heritage, Sukkur.

WHEREAS It is expedient to provide for the establishment of a Preamble. University known as the Aror University of Art, Architecture, Design and Heritage, Sukkur and to provide for the matters connected therewith or ancillary thereto:

It is hereby enacted as follows:-

CHAPTER-I PRELIMINARY

(1) This Act may be called the Aror University of Art, Short title and Architecture, Design and Heritage, Sukkur, Act, 2019. commencement.

- (2) It shall come into force at once.
- 2. In this Act unless there is anything repugnant in the Definitions. subject or context—
 - (a)"Academic Council" means the Academic Council of the University;
 - (b) "affiliated college" means a College affiliated to the University;
 - (c) "Authority" means any of the Authorities of the University specified in section 22;
 - (d)"Chancellor" means the Chancellor of the University;
 - (e) "Chairman" means the head of a Teaching department established by the University;
 - (f) "Chief Minister" means the Chief Minister of Sindh;
 - (g) "College" means a college and includes an institution, in which arrangements exist for imparting instructions or practical training, in courses of studies relating to art, architecture, design, heritages and such other allied subjects as may be prescribed;
 - (h) "Commission" means the Sindh Higher Education Commission established under the Sindh Higher Education Commission Act, 2013 (Sindh Act No.XI of 2013);
 - (i) "constituent college" means a college maintained and administered by the University;
 - (j) "Dean" means the Head of a Faculty;
 - (k) "Director" means the head of an institute established as constituent institute by the university;
 - (I) "educational institution" means an institution **imparting** instruction in a subject or subjects relating to a faculty;
 - (m)"Faculty" means a Faculty of the University;
 - (n) "Government" means the Government of Sindh;
 - (o)"Higher Education Commission Pakistan" means the Commission established under Higher Education Commission Pakistan Ordinance 2002;
 - (p)"Honorary Professor" means a professor who provides academic services on honorary basis;
 - (q) "Officer" means any of the officers of the University specified in section 9;
 - (r) "prescribed" means prescribed by Statutes, Regulations or Rules;
 - (s) "Principal" means the Head of a college;
 - (t) "Pro-Chancellor" means the Pro-Chancellor of the University;
 - (u)"Pro Vice-Chancellor" means the Pro Vice-Chancellor of the University;

- (v) "Professor Emeritus" means a retired Professor working in the University in an honorary capacity;
- (w) "registered graduate" means a graduate of the University whose name has been entered in the register maintained for this purpose and includes a graduate and post graduate in any of the subjects prescribed by or under this Act and residing within the territorial jurisdiction of the University and his name entered in the register maintained by the University for the purpose;
- (x) "Registrar" means the Registrar of the University;
- (y) "Regulations" means the Regulations made or deemed to have been made under this Act;
- (z) "Research Officer" means a person engaged whole-time by the University for research and equivalent in rank to a university Teacher;
- (aa) "Rules" means the Rules made or deemed to have been made under this Act;
- (bb) "Senate" means the Senate of the University;
- (cc) "Statutes" means the Statutes made or deemed to have been made under this Act;
- (dd) "Syndicate" means the Syndicate of the University;
- (ee) "Teacher" includes Professor, Associate Professor, Assistant Professor and Lecturer engaged whole time by University or by the college for imparting instructions in the University or a college on any prescribed course or courses and includes a person declared as such by Regulations;
- (ff) "Teaching Department", means a Teaching Department established and maintained, or recognized by the University;
- (gg) "University" means the Aror University of Art, Architecture, Design and Heritage, Sukkur;
- (hh) "Vice-Chancellor", means the Vice-Chancellor of the University;
- (ii) Visiting teacher" means a teacher who is invited for teaching by the University for a short period.

CHAPTER-II THE UNIVERSITY

The University to be called the Aror University of Art, Incorporation. 3. Architecture, Design and Heritage, Sukkur is established in accordance with the provision of this Act.

- The University shall consist of
 - the Chancellor:
 - the Pro-Chancellor
 - iii. the Vice-Chancellor.
 - iv. the Pro-Vice Chancellor, Deans, Principals of the colleges, Directors of the constituent institutions, Chairman of teaching departments, Registrar, Director Finance, Deputy Director Finance, Resident Auditor, Controller of Examinations, Project Director, Director Planning and such other officers as may be prescribed;
 - v. the members of the Senate, the syndicate, the Academic Council and other Authorities of the University;
 - vi. all University teachers; and
 - vii. Professors Emeritus;

Provided that the Chief Minister may set up inany educational institution or college under the control and management of the University and establish a Board of Governors under section 40, in lieu of the Officers and employees mentioned in subclause (b) of clause (1).

- The University shall be a body corporate having perpetual succession and a common seal with power among others, to acquire, hold and dispose of any property both movable & immovable vesting in it and shall by the aforesaid name sue and be sued.
- The University shall be competent to acquire and hold property, both movable and immovable, or lese, sell or otherwise transfer any moveable and immovable property which may have vested in or been acquired by it or enter into contract for the purpose of this Act.
- All properties and assets, right and interest of whatever Assets and 4. kind, used, enjoyed, possessed, owned or vested in, or held Liabilities and in trust by the Quald-e-Awam University of Engineering, Science and Technology in respect of Sindh College of Art and Design Sukkur and all liabilities legally subsisting against it immediately before the commencement of this Act, shall stand transferred to the University.

All persons serving in the Quaid-e-Awam University of Engineering, Science and Technology in respect of Sindh College of Art and Design Sukkur in any capacity immediately before the commencement of this Act, if they opt to serve in the University, shall, notwithstanding any law or terms and conditions of their service, stand transferred for service to the University on the terms and conditions as may be prescribed:

Provided that such terms and conditions shall not be less favourable than the terms and conditions admissible to them immediately before their transfer.

- (3) The option under sub-section (2) shall be exercised and submitted to Universities and Boards Department within ninety days of the commencement of this Act and the option so exercised shall be final.
- The University shall have the powers-

Powers of the University.

- (i) to provide for instructions and research in, and advancement and dissemination of knowledge of, Art, Architecture, Design and Heritages including training, research, demonstration, diploma, certificates and such other allied subjects as may be prescribed;
- (ii) to prescribe courses of studies to be taught in the University and colleges;
- (iii) to hold examinations and confer degrees for graduate and post graduate, diplomas, certificates and other academic distinction on person who have, under the prescribed conditions have been admitted to and passed its examinations;
- (iv) to confer, in the prescribed manner, honorary degrees or other academic distinctions on such person;
- (v) to confer degrees on persons who have done independent research under prescribed conditions;
- (vi) to provide for teaching specified courses or training for persons not being the students of the College, grant certificates and diplomas to such persons;
- (vii) to affiliate or disaffiliate colleges in the prescribed manner;
- (viii) to admit colleges to its privileges or withdraw such privileges from them in the prescribed manner;
- (ix) to inspect colleges affiliated or seeking affiliation;
- (x) to conduct classes and confer degrees in subjects relating to Art, Architecture, Design and Heritages;
- (xi) to accept the examinations passed or the periods of study spent at other college or places of learning, as equivalent to examinations or periods of study in the University or withdraw such acceptance;
- (xii) to cooperate with other colleges or universities or public authorities in such manner and for such purposes as it may determine;
- (xiii) to create posts in connection with teaching, research, extension, administration, training and for any other purposes related thereto and appoint persons there against;

- (xiv) to recognize any teacher of an affiliated college or such other person as teacher;
- (xv) to institute and award fellowships, scholarships, bursaries, medals and prizes in the prescribed manner;
- (xvi) to establish Teaching Department, colleges, faculties, institutes, centers of excellence, museums, art galleries and other centers of learning for the development of teaching and research and make such arrangements for their maintenance, management and administration, as it may determine;
- (xvii)to provide for instruction, training, research, demonstration, diplorna, certificates and to award the degree under graduate and post graduate levels in the fields of art, architecture, design and heritage, as prescribed;
- (xviii) to control the residence of the students of the University and the colleges, institute and maintain halls of residence and approve any place as hostel or lodging of students;
- (xix) to supervise and control the discipline of the students of the University and Colleges and promote the extracurricular and recreational activities of such students and made arrangements for promoting their health and general welfare;
- (xx) to take disciplinary action against, and Impose penalty on students in the prescribed manner;
- (xxi) to charge and receive such fees and other payments as it may determine;
- (xxii)to receive and manage property transferred, and grants, bequests, trusts, gifts, donations, endowments and other contributions made to the University, and invest any fund representing such property, grants, bequests, trusts, gifts, donations, endowments or contributions in such manner as it may deem fit; '
- (xxiii) to provide for the printing and publication of research and other works; and
- (xxiv) to do such other acts or things, whether incidental to the power aforesaid or not, as may be necessary to further the objects of the College University as a place of education, learning and research, and as teaching, affiliating and examining body.
- Notwithstanding anything contained in any law, for the time Jurisdiction of 6. being in force, the University shall have jurisdiction within the University. the limit of its campus and in respect of colleges in such areas within the Province of Sindh as may be notified by Government:

Provided that Government may, in consultation with the University, by general or special order modify the Jurisdiction.

- (2) No educational institution situated within the territorial limits of the University shall, save with the consent of the. University and the sanction of Government, be associated in any way with or seek admission to the privileges of any other University.
- The University may admit to its privileges under prescribed conditions, an educational institution falling within the territorial limits of another university whether inside or outside Pakistan, provided that the consent of such other University is first obtained.
- 7. (1) The University shall be open to all persons of either sex and of whatever religion, race, caste, creed, class or colour and no person shall be denied the privileges of the University on the grounds only of sex, religion, race, caste, creed, class or colour:

Open to all classes, creeds,

Provided that nothing in this section shall be deemed to prevent religious instruction being given to the students in their own religious faiths in such manner as may be prescribed.

- Government may issue guidelines and principles with (2) respect to admission in the University including its constituent colleges and constituent institutions.
- The Academic Council shall frame admission policy in (3) consonance with guidelines and principles.
- All recognized teaching in various courses in the University Teaching at the (1) or the Colleges shall be conducted in the prescribed University. manner, and it may include lectures, tutorials, discussions, demonstrations, practical seminars, work laboratories/studios/workshop and other methods instruction.

- The teaching in any prescribed course in the University or colleges shall be organized by such Authority as may be prescribed.
- The courses and the curricular for teaching in the colleges (3) shall be such as may be prescribed. Provided that at the level of bachelor's degree, in all faculties a discipline to be called the Islamic and Pakistan Studies Discipline shall be compulsory for Muslim students, and non-Muslim students shall in lieu of such discipline have option to offer Ethics and Pakistan Studies.

CHAPTER - III OFFICER OF THE UNIVERSITY

The following shall be the officers of the University:-9.

Officers of the University

The Chancellor; (i)

- (ii) The Pro Chancellor;
- (iii) The Vice Chancellor;
- (iv) The pro Vice-chancellor;
- (v) Deans;
- (vi) Principals of the colleges;
- (vii) Directors of the constituent institutions;
- (viii) Chairman of teaching departments;
- (ix) Registrar;
- (x) Director Finance or Chief Financial Officer;
- (xi) Chief Accountant;
- (xii) Resident Auditor;
- (xiii) Controller of Examinations;
- (xiv) Project Director;
- (xv) Director Planning;
- (xvi) -Librarian;
- (xvii) and such other officers/members of the Authority as may be prescribed;
- The Governor of Sindh shall be the Chancellor of the Chancellor. University.
 - (2) The Chancellor shall, when present, preside at Convocation of the University.
 - (3) Every proposal to confer an honorary degree shall be subject to confirmation by the Chancellor.
 - (4) If the **Chief Minister** is satisfied that the proceedings of any Authority are not in accordance with the provisions of this **A**ct, the statutes, the regulations, or the rules, he may, after calling upon such Authority to show cause why such proceedings should not be annulled, by order in writing, annul the proceedings.
 - (5) The **Chief Minister** shall have the power to assent to such statutes as are required to be submitted to him by the senate or withhold assent and refer them back to the senate for reconsideration.
 - (6) The **Chief Minister** may remove any person from the membership of any Authority if such person -
 - (i) has become of unsound mind; or
 - (ii) has been incapacitated to function as member of such Authority; or
 - (iii) has been convicted by a court of law of an offence involving moral turpitude.
 - (7) The **Chief Minister** may, subject to the provisions of this Act, delegate all or any of the powers and functions of any Authority, officer or employee of the University at its main campus, to any authority, officer, employee or any other person at its additional campus for the purpose of exercising such powers and performing such functions in relation to such additional campus, and for this propose the **Chief Minister** may create new posts or positions at the additional campus.

The Chief Minister may cause an inspection or enquiry to Visitation. 11. (1) be made in respect of any affairs or matter directly or in directly concerned with the University and shall, from time to time, appoint such person or more persons for of carrying out to conduct such inspection of -

- the university, its buildings, laboratories, studios libraries, museum, workshops and equipments;
- any institution college or hostel maintained or 11. recognized by or affiliated to the University;
- iii. the teaching and other work conducted by the University; and
- iv. the conduct of examinations held by the University;
- (2) The Chief Minister shall, in every such case aforesaid, give notice to the Syndicate of his intention to cause an inspection or enquiry to be made, and Syndicate shall be entitled to be represented there at.
- (3)The Chief Minister shall communicate to the Syndicate his views with regard to the results of such inspection or enquiry and shall, after ascertain the views thereon of the Syndicate, advice the Syndicate on the action to be taken.
- (4) The Syndicate shall communicate to the Chief Minister such action, if any, as has been taken or may be proposed to be taken upon the results of the inspection or inquiry within' such time as may be specified by the Chief Minister.
- (5) Where the Syndicate does not, within a specified time, take action to the satisfaction of the Chief Minister, the Chief Minister may, after considering any explanation furnished or representation made by the Syndicate, issue such direction as he thinks fit, and the Vice Chancellor shall comply with such directions.
- 12. The Pro-Chancellor of the University shall be a Minister or Pro-Chancellor. Advisor as may be nominated by the Chief Minister.

- (2) Should the Chancellor be incapacitated from acting as such due to absence or any other cause, the Pro-Chancellor shall exercise all the powers and perform all the duties of the Chancellor.
- 13. (1) There shall be a Vice Chancellor of the University who shall be an eminent academic qualified to be full Professor and shall be appointed by the Chief Minister for a period of four years which may be extended for one more term only on such terms and conditions as the Chief Minister may determine.

Vice-Chancellor.

The Professional and Academic qualifications, experience and age for the post of Vice Chancellor shall be as such as may be determined by the Chief Minister.

- (3) At any time when the office of the Vice Chancellor is vacant, or the Vice Chancellor is absent or is unable to perform the functions of his office due to illness or some other cause, the **Chief Minister** shall make such arrangements for the performance of the duties of the Vice-Chancellor.
- (4) The Chief Minister shall, in case of allegations of gross misconduct, inefficiency, corruption, violation of budgetary provisions, moral turpitude, maladministration and mismanagement, remove the Vice Chancellor, on the basis of substantiated enquiry committee after giving him an opportunity of show cause notice against such removal.
- (5) The Vice Chancellor may avail leave with the permission of Chief Minister or any other authority duly authorized by the Chief Minister.
- 14. (1) The Vice Chancellor shall be the principal executive and academic officer of the University, and shall ensure that the provisions of this Act, the statutes, the regulations and the rules are faithfully observed in order to promote the general efficiency and good order of the University. He shall have all powers necessary for this purpose including administrative control over all officers, teachers and other employees of the University.

Powers and Duties of the Vice chancellor.

- (2) The Vice Chancellor shall, in the absence of the Chancellor and Pro-Chancellor, preside at the Convocation of the University and the meetings of the Senate and shall, if present, preside at the meetings of the Authorities of which he is the Chairman and be entitled to attend and preside at any meeting of any other Authority or body of the University.
- (3) The Vice Chancellor may, in an emergency, which in his opinion requires immediate action, take such action as he may consider necessary and shall, as soon thereafter as possible, report his action to the officer, authority or other body which in the ordinary course, would have dealt with the matter.
- (4) The Vice Chancellor shall also have the powers -
 - to create and fill temporary "teaching" posts for a period not exceeding six months; "subject to final approval of the Syndicate";
 - ii. to sanction all expenditure provided for in the approved budget, and to re appropriate funds within the same major head of expenditure;
 - iii. to sanction by re-appropriation of funds for an unforeseen item not provided for in the budget, and report it to the Syndicate at the next meeting;
 - to appoint paper setters "jurors, panel of experts, art critics" and examiners for all examinations of the University after receiving panels of names from the relevant authorities;

- v. to make such arrangements for the scrutiny of papers, marks and results as may be necessary;
- vi. to direct teachers, officers and other employees of the University to take up such assignments in connection with teaching, research, examination, administration and such other activities in the University as he may consider necessary for the purpose of University;
- vii. to delegate, subject to such conditions, if any, as may be prescribed, any of his powers under this Act to an officer or officers of the University;
- viii. to exercise general control supervision over the system of examination in the University;
- ix. **to** appoint employees of such categories in respect of which powers have been delegated to him by the Syndicate;
- x. to exercise and perform such other powers and functions as may be prescribed; and
- xi. to make appointments to the posts in all grades of the Basic Scales of pay up to grade 16.
- (5) The Vice Chancellor shall present annual reports before the Senate within three months of close of the academic year. The annual report shall present such information as regards the academic years under review as may be prescribed, including disclosure of all relevant facts pertaining to the academics, research, administration and finances.
- (6) The annual reports shall be made available prior to its presentation before the Syndicate to all officers and University teachers, and shall be published in such number as are required to ensure its wide circulation.
- 15. (1) The Pro-Vice Chancellor shall be from amongst the University Professors to be appointed by the Chief Minister for the main campus or of the additional campus, if any, or for both the campuses jointly or separately, on such terms and conditions and for such period not exceeding four years at time as may be determined by the Chief Minister.
 - (2) Where a Pro-Vice Chancellor is appointed under subsection, (1), he shall, notwith standing anything contained in this Act, exercise such powers and perform such functions of the Vice Chancellor or such other powers and functions, in respect of the campus for which he is appointed, as the Chief Minister may delegate to him.
 - (3) The Pro-Vice Chancellor, if appointed, shall be ex-officio member of the Senate, Syndicate and Academic Council.

Pro-Vice Chancellor. 16. (1) The Registral shall be a whole time officer of the Registrar. University and shall be appointed by the Syndicate on the recommendations of the Selection Board, on such terms and conditions as it may determine

(2) The Registrar shall

- (a) hold office for a period of three years on the expiry of which he shall be eligible for re appointment;
- (b) be the costodian of the common seal and the academic records of the University;
- (c) maintain a register of registered graduates in the prescribed manner;
- (d) conduct election of members to the various authorities in the prescribed manner; and
- (e) perform such other duties as may be prescribed.
- 17. (1) The Director of Finance shall be a whole time officer of the University and shall be appointed by Chief Minister from , a panel of three candidates recommended by the Search Committee on such terms and conditions as it may determine.

- The Director Finance shall $\cdot (2)$
 - (a) manage the property, finances and the investments of the University;
 - (b) be the Chief Finance officer of the University;
 - (c) prepare the annual and revised bridget estimates of the University and present them to the Finance Committee, the Syndicate and the Senate;
 - (d) ensure that the funds of the University are expended · for the purposes for which they are provided; an
 - (e) perform such other duties as may be prescribed.
- The experience as well as professional and academic (3) qualifications for the post of Director of Finance shall be such as may be prescribed
- The Director of Chiance shall be assisted by the Chief (4) Accountant, Bursar and the Resident Auditor.
- The Controller of Examinations shall be a whole time officer 18. of the University and shall be appointed by Syndicate on the recommendations of the Selection Board on such terms and conditions as it may determine. He shall be responsible for all matters connected with the conduct of examinations and perform such other duties as may be prescribed.

(1) . The Chief Accountant, Bursar and Resident Auditor shall be 19. whole time officers of the University and shall be appointed by the Syndicate on the recommendations of the Selection Board on such terms and conditions as it may determine.

The Chief Accountant, Bursar and Resident Auditor.

- (2) The Resident Auditor shall be whole-time officer of the University and shall be appointed by the Pro-Chancellor who shall be a Cabinet Minister on such terms and conditions as it may determine. He shall be responsible for all matters connected with the auditing of accounts of the University and shall perform such other duties as may be prescribed.
- The Director Planning and Development shall be whole-time officer of the University and shall be appointed by the Syndicate on the recommendations of the Selection Board on such terms and conditions as it may determine. He shall be responsible for the planning and development of the University and shall present the development plans and proposals to the Finance and Planning Committee and other relevant authorities of the University.

The Director Planning and Development.

21. All the other remaining officers mentioned in section 9, shall be appointed by such officer or authority as authorized by Government on such terms and conditions as it may determine. They shall perform their duties as may be prescribed.

- The Chief Minister or in his absence, the Pro-Chancellor (2) or in absence of both, the Vice-Chancellor shall be the Chairman of the Senate.
- The members of the Senate, other than ex-officio (3)members shall hold office for three years.
- The Senate shall meet at least twice in every year on (4) dates to be fixed by the Vice Chancellor with the consent of the Chief Minister.
- The quorum for a meeting of the Senate shall be one-(5) third of the total number of members, a fraction being counted as one.

Subject to the provisions of this Act, the Senate shall have Power and duties 24. the powers to

of the Senate.

(a) consider the drafts of statutes proposed by the Syndicate and dispose of them in the manner indicated in sub-section (2) of section 31;

- (b) consider and pass resolution on the annual report, the annual statement of accounts, and the annual and revised budget estimates;
- (c) appoint members to the Syndicate and other Authorities in accordance with the provisions of this Act;
- (d) delegate any of its powers to an Authority or Officer
 or a Committee or Sub Committee; and
- (e) perform such other functions as may be prescribed by the statutes.

25. (1) The Syndicate shall consist of

- (i) the Vice Chancellor, who shall be its Chairperson;
- (ii) the Pro-Vice Chancellor, if appointed to the extent of the matters relevant to the concerned campus;
- (iii) two members of the Provincial Assembly of Sindh to be nominated by the Speaker of Provincial Assembly;
- (iv) two members of the Senate to be elected by the Senate;
- (v) a Judge of the High Court of Sindh nominated by the Chief Justice;
- (vi) the Secretary to the Government of Sindh of relevant Department or his nominee not below the rank of an Additional Secretary;
- (vii) one nominee of the Higher Education Commission of Pakistan;
- (viii) the Secretary to Government of Sindh, Universities and Boards Department or his nominee not below the rank of an Additional Secretary;
- (ix) Chairperson of the Sindh Higher Education Commission or his nominee not below the rank of member of the Commission;
- one Dean to be nominated by the Chief Minister on the recommendations of the Vice-Chancellor;
- (xi) one Professor to be elected by the Professors of the University from amongst themselves;
- (xii) one Associate Professor to be elected by the Associate Professor of the University from amongst themselves;
- (xiii) one Assistant Professor of the University to be elected by the Assistant Professors from amongst themselves;
- (xiv) one lecturer with minimum service of two years to be elected by the lecturers of the University from amongst themselves;

- (xv) three persons of emmence being persons of distinction in the field of literature, architecture, administration, management, education, academics, science, technology and engineering to be nominated by the Chief Minister;
- (xvi) one Principal of an attiliated college, if any, and the Principals of constituent colleges to the extent of the matters relevant to the concerned constituent college to be nominated by the Vice Chancellor;
- (xvii) one Alim and one woman not serving in any educational institution to be nominated by the Chief Minister;
- (xviii)one University officer of Administration side, to be elected from amongst all administrative officers.
- The members of the Syndicate, other than ex-officio members, shall hold office for three years.
- The quorum for a meeting of the Syndicate shall be one-(3)half of the total number of members, a fraction being counted as one:
- The Syndicate shall be the executive body of the Power and duties 26. (1) University and shall subject to the provisions of this Act of the Syndicate. and the statutes, exercise general supervision over the affairs and the property of the University.

- Without prejudice to the generality of the foregoing (2) powers, and subject to the provisions of this Act and the Statutes, the Syndicate shall have the powers -
 - (a) to determine the form, provide for the custody and regulate the use, of the common seal of the University;
 - (b) to hold manage, receive, acquire in any manner or, transfer by sale or otherwise any movable or immovable property, on behalf of the University;
 - (c) to hold, administer, and control funds on behalf of the University and after giving due regard to the advice of the Finance and Planning Committee invest such funds in Government Securities or such other securities as may be prescribed;
 - (d), to consider the annual and revised budget estimates and advise the Senate thereon, and re-appropriate funds from one major head of expenditure to another,
 - to cause to be maintained books of accounts of all financial transactions including the assets and liabilities of the University;

- (f) to enter into, vary, carry out and cancel contracts on behalf of the University;
- (g) to provide buildings and other premises, libraries, furniture, apparatus, equipment and such other things required for the University;
- (h) to establish and maintain halls of residence and hostels for students and approve any place as hostel or lodging of students;
- (i) to affiliate and disaffiliate colleges;
- to admit colleges and educational institutions to the privileges of the University and withdraw such privileges;
- (k) to cause inspections to be made of the colleges and the Teaching Department;
- (I) to create posts in connection with teaching, research, extension, administration, training and for any other purposes related thereto;
- (m) to appoint, on the recommendation of the Selection Board, University Teachers and employees to posts in Basic Scale 17 and above;
- (n) to appoint Professors Emeritus on such terms and conditions as may be prescribed;
- to suspend, punish and remove from service, officers (other than the Vice Chancellor), Teachers, and other employees in the manner prescribed;
- (p) to appoint members to the various Authorities in accordance with the provisions of this Act;
- (q) to confer, subject to the approval of the Chancellor, Honorary Degrees in accordance with the conditions as may be prescribed;
- (r) to propose drafts of statutes for submission to the Senate;
- (s) to consider and approve regulations proposed by the Academic Council, or frame regulations after calling the advice of the Academic Council;
- (t) to cause to be prepared annual report as regards the affairs of the University for submission to and approval of the Senate;
- (u) to furnish report on any matter called for by the Senate;
- (v) to regulate, determine and administer all other matters concerning the University and to this end exercise all other powers not specifically mentioned in this Act and the statutes, as it may deem fit;

- (w) to create, suspend or abolish such administrative, research, extension or other posts as may be necessary;
- (x) to prescribe the duties of Officers, Teachers, and other employees of the University;
- (y) to delegate any of its powers to an Authority or Officer or a Committee or Sub-Committee; and

CHAPTER V STATUTES, REGULATIONS AND RULES

 - (b) constitution, powers and duties of the Authorities and conduct elections to such Authorities and matters related thereto;
 - (c) the maintenance of the register of registered graduate;
 - (d) the attiliation and disaffiliation of colleges and educational institutions and related matters;
 - the establishment of Faculties, Teaching Departments, institutes and colleges and other academic units and divisions;
 - the admission of educational institutions to the (f) privilege of the University and the withdrawal of such privileges;
 - the powers and duties of officers, teachers and (g) other employees of the University;
 - conditions under which the University may enter (h) into arrangements with other public or private institutions for the purposes of instruction, research and other scholarly activities;
 - conditions of appointment of Professors Emeritus (1) and award of honorary degrees;
 - efficiency and discipline of the employees of the (j) University including Officers and teachers;
 - the general scheme of studies including the (k) duration of courses and the number of subjects and papers for examinations;
 - acquisition and administration of properties and (1)investments of the University; and
 - all other mattes which under this Act are required (m) to be or may be prescribed or regulated by the statutes.

(2) The Syndicate shall make a proposal for any statutes to the Senate which may after considering the proposal, approve it with or without any modifications or refer it back to the syndicate for reconsideration, or reject it:

> Provided that the statutes affecting the constitution or powers of the Authority shall not be proposed until. such Authority has been given an opportunity of expressing its opinion in writing on the proposal:

> Provided further that the statutes in respect of any matter mentioned in clause (a) of sub-section (1), passed by the Senate shall not be affective until they have been approved by the Chief Minister:

Provided also that statutes in respect of the matter mentioned in clause (j) shall be made by the Chief Minister.

32: Subject to the provisions of this Act and the statutes, Regulations. (1) regulations may be made for all or any of the following matters, namely:-

- the courses of studies for degrees, diplomas and (a) certificates of the University;
- (b) the manner and method of teaching conducted in the University and the colleges;
- the admission of students to the University and (c) conditions under which they shall be admitted to the courses and the examination of the University shall become eligible for the award of degrees, diplomas and certificates;
- the conduct of examinations; (d)
- the fees and other charges to be paid by students (e) for admission to the courses of studies and the examination of the University;
- the conduct and discipline of the students of the (f) University;
- the residence of the students of the University or **(g)** the colleges, and fees for residence in halls of residence and hostels and approval of hestels and lodgings for students;
- conditions for carrying out independent research (h) for acquiring a degree;
- institution of fellowships, scholarships, (i) exhibitions medals and prizes;
- the academic costumes; (i)
- the use of Library; (k)
- the formation of Teaching Departments and Board (1)of Studies; and

- all other matters which by this Act, or statutes are to be or may be prescribed by the regulations.
- (2) The Academic Council shall prepare and submit the regulations to the Syndicate, which may approve them with or without modifications or refer them back to the Academic Council for reconsideration, or reject them.
- 33. (1) The Authorities and the other bodies of the University may Rules. make rules consistent with this Act, statutes and the regulations, to regulate the conduct of their business and the time and place of meetings and related matters:

Provided that the Syndicate may direct the amendment or the annulment of any rules, made by any Authority or body excepting the Senate, under this section:

Provided further that if such other Authority or body is dissatisfied with such direction it may appeal to the Senate whose decision in the matter shall be final.

- (2) The Syndicate may make rules to regulate any matter relating to the affairs of the University which has not been specifically provided for by this Act, the statutes or regulations.
- 34. The procedure for adding to, amending or repealing the statutes and the regulations shall be the same as that prescribed respectively for framing or making statues and regulations.

Amendment and repeal of statutes and regulations.

35. (1) An educational institution applying for affiliation to the Affiliation. University shall make an application to the University and shall satisfy it -

- that the educational institution is under the (i) management of the Government or of a regularly constituted governing body;
- that the financial resources of the educational institution are sufficient to enable it to make due provision for its continued maintenance and efficient working;
- (iii) that the strength and qualifications of the teaching and other staff, and the terms and conditions of their service, are adequate to make due provision for the courses of instruction, teaching or training to be undertaken by the educational institution;
- (iv) that the educational institution has framed proper rules regarding the efficiency and discipline of its staff and other employees;

- that the building in which the educational institution is to be located is suitable, and that provision will be made inconformity with the statutes and the regulations for the residence of students, not residing with their parents or guardians, in the hostels established and maintained by the educational institution or in hostels or lodgings approved by it, and the supervision and physical and general welfare of students:
- (vi) that provision has been made for Library and adequate library services;
- (vii) that where affiliation is sought in any branch of experimental sciences, due arrangements have been made for imparting instruction in that branch of science in a properly equipped laboratory, museum and other places of practical work;
- (viii) that due provision will, so far as circumstances may permit, be made for the residence of Principal and members of the teaching staff in or near the college or the place provided for the residence of students; and
- (ix) That the affiliation of the educational institution, having regard to the provision which may have been made for students by another educational institution in its neighborhood, will not be injurious to the interests of education or discipline.
- The application shall further contain an undertaking that. (2) after the educational institution is affiliated any transference of, and changes in the management and in the teaching staff shall be forthwith reported to the University, and that the teaching staff shall possess such qualifications as are or may be prescribed.
- The procedure to be followed in disposing of an application (3) for the affiliation of an educational institution shall be such as may be prescribed.
- The Syndicate may, on the recommendation of the (4) Affiliation Committee, grant or refuse affiliation to an educational institution:

Provided that affiliation shall not be refused, unless the educational institution has been given an opportunity of making a representation against the proposed decision.

Where an educational institution desires to add to the Addition of courses of instructions in respect of which it is affiliated, the procedure prescribed under sub-section (3) of section 35 shall, so far as may be, be followed.

courses by affiliated educational Institution.

(1) Every educational institution affiliated to the University 37. shall furnish such reports, returns and other information as the University may require enabling it to judge the efficiency of the educational institution.

Reports from affiliated educational institution.

- (2) The University may call upon any educational institution affiliated to it to take, within a specified period, such action as may appear to the University to be necessary in respect of any of the matters referred to in sub-section (1) of section 35.
- 38. (1)If an educational institution affiliated to the University fails at any time to fulfill any of the requirements mentioned in this Act, or if an institution has failed to observe any of the conditions of its affiliation, or its affairs are conducted in a manner which is prejudicial to the interest of education, the Syndicate may, on the recommendation of the Affiliation Committee, and after considering such representation as the educational institution may wish to make, withdraw, either in whole or in part, the rights conferred on the educational institution by affiliation or modify such rights.

Withdrawal of affiliation.

- (2) The procedure to be followed for the withdrawal of affiliation shall be such as may be prescribed,

- control and administer the property of the (ii) institution or college;
- manage and regulate the funds, finances, assets (iii) and investments of the institution or college;
- maintain the accounts of the institution or college (iv) in the prescribed form and get such accounts audited in the prescribed manner; and
- appoint teachers and other employees of the institution or college and have the power to take disciplinary action against them.

CHAPTER VI UNIVERSITY FUND

There shall be fund for the University to be called the University Fund. University Fund to which shall be credited all moneys received by the University from fees, donations, trusts, bequests, endowments, contributions, grants and other sources.

Accounts.

- The accounts of the University shall be maintained in such Audit and 42. (1)form and in such manner as may be prescribed.
 - No expenditure shall be made from the funds of the . (2) University unless a bill for its payment has, in accordance with the statutes, been audited by the Resident Auditor and the payment is included in the approved budget of the University.
 - The accounts of the University shall, in the prescribed. (3) manner, be audited once a year by the Auditor appointed. by the Syndicate.
 - The annual statement of the accounts of the University (4) signed by the Director of Finance and the Resident Auditor shall be submitted to Government within six months of closing of the financial year.
 - The accounts of the University together with audit objections, if any, and the observations of the Government Auditor and the Director of Finance shall, in the prescribed manner, be presented to the Syndicate.

CHAPTER-VII GENERAL PROVISIONS

An officer, teacher or other employee of the University Retirement from shall retire from the service of the University service.

(i) on such date, after he has completed twenty five years service qualifying for pension or other retirement benefits, as the competent authority may direct: Provided that no employee shall be retired

unless he has been informed in writing of the grounds of the action proposed to be taken against him and has been given reasonable opportunity of showing cause against that action; or

- (ii) where no direction is given under clause (i), on the completion of sixty years age. Explanation: In this section "competent authority" means the appointing authority or a person duly authorized by the appointing authority in that behalf, not being a person lower in rank to the officer, teacher or other employee concerned.
- Except as otherwise provided in this Act, no officer, teacher or other employee of the University holding a permanent post shall be reduced in rank, or removed or compulsorily retired from service, unless he has been given reasonable opportunity of showing cause against the action proposed to be taken against him.

Opportunity to show cause.

45. (1) Where an order is passed punishing any officer (other than the Vice Chancellor), teacher or other employee of the University or altering or interpreting to his disadvantage the prescribed terms or conditions of his service, he shall, where the order is passed by the Vice Chancellor or any other officer or teacher of the University, have the right to appeal to the Syndicate against the order, and where the order is made by the Syndicate, have the right to apply to that authority for review of that order.

Appeal to review.

- (2) The appeal or application for review shall be submitted to the Vice Chancellor and he shall lay it before the Syndicate with his views along with the record of the case.
- (3) No order in appeal or review shall be made unless the appellant or the applicant, as the case may be, has been given an opportunity of being heard.
- 46. The University shall constitute for the benefit of its (1) officers, teachers and other employees in such manner and subject to, such conditions as may be prescribed. such pension, insurance, gratuity, provident funds and benevolent fund scheme as it may deem fit.

Pension Insurance, Gratuity Provident Fund and Benevolent Fund.

- Where any provident fund has been constituted under this (2) Act, the provisions of the Provident Funds Act, 1925 (Act No.XIX of 1925) shall apply to such funds as if it were the Government Provident Fund.
- When a member of a newly constituted Authority is Commencement (1) elected, appointed or nominated, his term of office, as fixed under this Act, shall commence from such date as may be prescribed.

- (2) Where a member nominated or elected to any Authority, fails to attend three meetings consecutively, he shall' cease to be the member.
- (3)Where a member who has accepted any assignment or for any such other reason, remain absent from the University for a period not less than six months, he shall be deemed to have resigned and vacated his seat.
- 48. Any casual vacancy among the elected, appointed or nominated members of any Authority shall be filled, as soon as conveniently may be, by the person or persons or the body who elected, appointed or nominated the member whose place has become vacant and the person elected, appointed or nominated to vacancy, shall be a member of such Authority for the residue of the term for which the person whose place he fills would have been a member.

Filling of casual vacancies in Authorities.

49. Where there is void in the constitution of an Authority as constituted by this Act, because of the abolition of a specified office under Government or because an the Authorities. organization, institution or other body outside the University has been dissolved or has ceased to function or because of some other similar reason, it has become difficult to fill the vacancy, such vacancy shall be filled in such manner and, subject to such conditions as the Chief-Minister may direct.

50. When a dispute arises if any person is eligible to become. Dispute about or continue as member of any Authority, the matter shall membership of be referred to a committee consisting of the Vice Authorities. Chancellor and the Judge of the High Court, who is the member of the Syndicate and a nominee of the Chief Minister and the decision of the committee shall be final and binding.

No act, proceedings, resolution of decision of any authority 51. shall be invalid by reason of any vacancy of defect in the constitution of, or in the appointment of nomination of any member of the Authority.

Proceedings of **Authorities** of not invalidated by vacancies.

Notwithstanding anything contained in this Act, the 52. statutes set out in the Schedule to this Act, shall be deemed to be the statues framed under section 31 and shall continue to remain in force until they are amended or replaced by new statutes framed in accordance with the provisions of this Act.

First Statutes.

No court shall have jurisdiction to entertain any 53. proceedings, grant any; injunction or make any order in relation to anything done in good faith or purported to have been done or intended to be done under this Act.

Bar of Jurisdiction. 54. No suit or legal proceedings shall be against Government, the University or any Authority, officer or employee of Government or University or any person in respect of anything which is done or purported to have been done in good faith or is intended to or has been done under this Act.

Indemnity..

55. Notwithstanding anything contained herembefore

> (a) any officer, teacher or other employee of the University shall as the Chief Minister may in the public interest direct, serve in any post under Government or any other University or an educational or research institution; provided that in the case of a teacher, the Syndicate shall be consulted before issuing the direction;

Powers to require officers, teachers or: employees to serve under any organization.

- (b) the Chief Minister may, in the public interest, direct, any post in the University to be filled by appointing any employee of Government or any other University or an educational or research institution; provided that in the case of a teacher, the Selection Board shall be consulted before filling in the post.
- (2) Where any appointment or transfer has been made under this section, the ferms and conditions of service of the appointee or transferee shall not be less favorable than those admissible to him immediately before such appointment or transfer and he shall be entitled to all benefits of his past service.

Notwithstanding the repeal of the notification and (2) legislative instruments envisaged under sub-section (1), everything done, action taken, obligations or liabilities incurred, rights and assets acquired, persons appointed or authorized, jurisdiction or powers conferred, endowments, bequests, funds or trusts created, donations or grants made, scholarships, studentships, or exhibitions instituted, or privileges granted or orders issued by the Sindh College of Art and Design Sukkur shall, if not inconsistent with the provisions of this Act or the statutes, the regulations or the rules made under this Act, be

continued and, so far as may be, be deemed to have been respectively done, taken, incurred, acquired, appointed, authorized, conferred, created, made, instituted, granted and Issued under this Act.

(1) . The University shall include the following Faculties:-

- the Faculty of Fine Art;
- (ii) the Faculty of Architecture;
- (iii) the Faculty of Design;

- The quorum for a meeting of the Board of a Faculty shall be one-half of the total number of members, a fraction being counted as one.
- The Board of each Faculty shall, subject to the general control of the Academic Council and the Syndicate, have the powers -
 - (a) to coordinate the teaching and research work in the subject assigned to the Faculty;

- (b) to scrutinize the recommendations of the Board of Studies comprised in the Faculty, on the appointment of paper setters and examiners, except for research examiners and forward them to the Vice Chancellor;
- (c) to consider any other academic matter relating to the Faculty and to report thereon to the Academic Council; and
- (d) to perform such other functions as may be prescribed
- There shall be a Dean of each Faculty who shall be the. Dean. (1) Chairman and convener of the Board of Faculty.
 - The Dean of each Faculty shall be appointed by the Chief (2) Minister on the recommendations of the Vice Chancellor from amongst the three most senior Professors in the Faculty for a period of three years.
 - The Dean of each Faculty shall be appointed by the Chief (3)Minister on the recommendations of the Vice Chancellor from amongst the three most senior Professors in the Faculty for a period of three years.
 - The Dean shall exercise such other powers and perform (4) such other duties as may be prescribed.
- There shall be a feaching Department for each subject or Teaching 3. (1) a group of subjects as may be prescribed by regulations and each Teaching Department shall be headed by a Chairman.

- The Chairman of the Teaching Department shall be (2) appointed by the Syndicate on the recommendations of the Vice Chancellor from amongst three most senior Professors or Associate Professors of the department for a period of three years: Provided that where there is no Professor or Associate in a Department, it shall be looked after by the Dean of the Faculty with the assistance of the most senior teacher of the Department.
- The Chairman of the Teaching Department shall plan, (3) organize and supervise the work of the Department in accordance with the provisions of this Act and shall be responsible to the Dean of the Faculty in which his Department is comprised for the work of his Department.
- There shall be a separate Board of Studies for each Boards of (1) subject or group of subjects, as may be prescribed by the Studies. regulations.

- (2) Each Board of Studies shall consist of-
 - (a) the Chairman of the Teaching Department;
 - (b) all Professors and Associate Professors in the Teaching Department concerned;
 - (c) three Assistant Professors and one lecturer to be appointed by rotation in order of seniority from , the Department concerned;
 - (d) three teachers other than the teachers to be appointed by the Syndicate. The number will be determined by the Syndicate according to the needs of each Board;
 - (e) one expert to be appointed by the Vice-Chancellor; and
 - (f) one representative of the teachers of each affiliated college teaching at graduate and postgraduate levels in that subject to be nominated by the Academic Council.
- (3) The term of office of members of the Board of Studies other than ex-officio members shall be three years.
- (4) The quorum for meetings of the Board of Studies shall be one-half of the total number of members, a fraction being counted as one.
- (5) The Chairman of the Teaching Department concerned shall be the Chairman and convener of the Board of Studies. Where in respect of a subject there is no Teaching Department, the Chairman shall be appointed by the Syndicate.
- (6) The functions of the Board of Studies shall be -
 - (a) to advise the Authorities on all academic matters connected with instruction, research and examination in the subject or subjects concerned;
 - (b) to propose curricula and syllabi for all degree, diploma and certificate courses in the subject or subjects concerned;
 - (c) to suggest a panel of names of paper-setters' and examiners in the subject or subjects concerned; and
 - (d) to perform such other functions as may be prescribed by regulations.
- 5. (1) There shall be Advanced Studies and Research Board consisting of -

Advanced Studies and Research Board.

- (i) the Vice Chancellor, who shall be the Chairman;
- (ii) the Deans;
- (iii) three University Professors other than Deans to be appointed by the Syndicate;

- (iv) three University Teachers having research qualifications and experience to be appointed by the Academic Council; and
- (v) the Professors Emeritus:
- (2) The term of office of members of the Advanced Studies and Research Board other than ex officio members shall be three years.
- (3) The quorum for a meeting of the Advanced Studies and Research Board shall be one half of the total number of members, a fraction being counted as one.
- (4) The functions of the Advanced Studies and Research Board shall be
 - (a) to advise the Authorities on all matters connected with the promotion of advanced studies and research in the University;
 - (b) to propose regulations regarding the award of research degrees;
 - (c) to appoint supervisors for research students and to determine the subjects of their thesis;
 - (d) to recommend panels of names of paper setters and examiners for research examinations after considering the proposals of the Board of Studies in this behalf; and
 - (e) to perform such other functions as may be prescribed by the statutes.
- 6. (1) The Selection Board shall consist of -

Selection Board and Selection Committee.

- (i) the Vice Chancellor who shall be the Chairman;
- (ii) the Chairman, or a member of the Sindh Public Service Commission to be appointed by the Chairman;
- (iii) Secretary Universities and Boards;
- (iv) one member of the Syndicate and two other persons of eminence to be nominated by the Syndicate; provided that none of them is an employee of the University;
- (v) Dean of the Faculty concerned; and
- (vi) the Chairman of the Teaching Department concerned.
- (2) The members mentioned in sub-clause (iii) of clause (1) shall hold office for two years.
- (3) The quorum for meeting of the Selection Board shall be four members.

- (4) No member of the Selection Board who is a candidate for the post to which appointment is to be made shall take part in the proceeding of the Selection Board.
- (5) In selecting candidates for the posts of Professors and Associate Professors, the Selection Board shall co-opt or consult three experts in the subject concerned, and in selecting candidates for other teaching posts, two experts in the subject concerned, to be nominated by the Vice Chancellor, from a standing list of experts for each subject approved by the Syndicate on the recommendation of the Selection Board and revised from time to time.
- (6) The Selection Committee shall consist of Chairman and such number of Members as may be appointed by the Vice Chancellor.
- 7. (1) The Selection Board shall consider the applications for teaching and other posts received in response to an advertisement and shall recommend to the Syndicate the names of suitable candidates for appointment to such posts.

Functions of Selection Board and Selection Committee.

- (2) The Selection Board may recommend the grant of a higher initial pay in a suitable case for reasons to be recorded.
- (3) The Selection Board may recommend to the Syndicate the appointment of an eminently qualified person to a Professorship in the University on the terms and conditions other than those prescribed.
- (4) The Selection Board shall consider all cases of promotion of officers of the University and recommend to the Syndicate the names of suitable candidates as may be prescribed.
- (5) In the event of an unresolved difference of opinion between the Selection Board and the Syndicate, the matter shall be referred to the **Chancellor** whose decision shall be final.
- (6) There shall be one or more Selection Committees which shall consider the applications for the posts in BS-16 and below in response to an advertisement and shall recommend to the Vice Chancellor the names of suitable candidates for appointment to such posts.
- (1) There shall be Finance and Planning Committee consisting of

Finance and Planning Committee.

- (a) the Vice-Chancellor who shall be the Chairman;
- (b) one member of the Senate to be appointed by the Senate;

- (c) one member of the Syndicate to be appointed to be appointed by the Syndicate;
- (d) one representative each from Universities and Boards Department and Finance Department not below the rank of Deputy Secretary;
- (e) two Deans to be nominated by the Chancellor on the recommendations of the Vice Chancellor;
- (f) one nominee of the Sindh Higher Education Commission; and
- (g) the Director of Finance who shall act as Secretary;
- (2) The term of office of the members of the Finance and Planning Committee other than ex-officio members shall be three years.
- (3) The quorum for a meeting of the Finance and Planning Committee shall be three members.

The functions of the Finance and Planning Committee shall be-

Functions of the Finance and Planning Committee.

- (a) to consider the annual statement of accounts and the annual and revised budget estimates and advise the Syndicate thereon;
- (b) to review periodically the financial position of the University;
- to advise the Syndicate on all matters relating to planning, development, finance, investment and accounts of the University;
- (d) to prepare short term and long term development plans; and
- (e) to perform such other functions as may be prescribed
- 10. (1) There shall be an Affiliation Committee consisting of -

Affiliation Committee.

- (i) the Vice-Chancellor who shall be the Chairman;
- (ii) one member of the Syndicate to be nominated by the Syndicate; and
- (iii) two Professors to be nominated by the Academic Council.
- (iv) the Director Education (Colleges) of the region concerned.
- (2) The term of office of the appointed members of the Committee excluding ex-officio members shall be two years.
- (3) The Affiliation Committee may co-opt not more than three experts.

- (4) An officer of the University to be designated by the Vice Chancellor for this purpose shall act as the Secretary of the Committee.
- 11. (1) The Disciplinary Committee shall consist of --

Disciplinary Committee.

- (a) the Vice-Chancellor or his nominee;
- (b) two Professors to be nominated by the Academic Council;
- (c) one member to be nominated by the Syndicate; and
- (d) The Teacher or Officer in-charge of Students.

 Affairs by whatever name called (Member-Secretary).
- (2) The term of office of the members of the Disciplinary Committee, excluding ex-officio members, shall be two years.
- (3) The quorum for a meeting of the Disciplinary Committee shall be four members.
- (4) The functions of the Disciplinary Committee Shall be -
 - (i) to propose regulations to the Academic Council for the conduct of University students, maintenance of discipline and for dealing with, cases of indiscipline, and
 - (ii)to perform such other functions as may be prescribed by the regulations.

AN ACT

to amend the Aror University of Art, Architecture, Design and Heritage, Sukkur, Act, 2019.

WHEREAS it is expedient to amend the Aror University of Preamble. Art, Architecture, Design and Heritage, Sukkur, Act, 2019, in the manner hereinafter appearing;

It is hereby enacted as follows:-

 This Act may be called the Aror University of Art, Short title and Architecture, Design and Heritage, Sukkur (Amendment) Act, commencement. 2025

- (2) It shall come into force at once.
- In the Aror University of Art, Architecture, Design and Amendment of Heritage, Sukkur, Act, 2019, hereinafter referred to as the said Act, in section 5 -

section 19 of Sindh Act No.IX of 2020.

In the said Act, in section 23, in sub-section (1), in clause Amendment of (xvii), for the words "and archaeology", the words "archaeology and allied fields or departments" shall be substituted.

section 23 of Sindh Act No.IX of 2020.

- In the said Act, in the Schedule, in clause 1, in sub-clause (1) -
 - (a) for clause (ii), the following shall be substituted:-
